SC SAVIN

WHAT IS IT?

- SAVIN service allows you, as the victim, to confirm that an offender is in jail, as well as update you with important custody status information.

WHAT DO I NEED TO DO?

- No! This entire service is confidential.

HOW CAN THEY ASSIST ME?

After sending in an application (either with your victim advocate or on your own), and qualifying for assistance, they* can provide:

- Up to 20 sessions of professional counseling
- Up to \$6,500 in funeral costs
- Medical and dental costs
- Lost wages because of injury
- Up to a combined total of \$15,000

They are a payer of last resort; this means if you have insurance, it must be filed/processed first

WHO QUALIFIES FOR ASSISTANCE?

Victims of crime and family members who meet the qualification requirements.
